Program Information

The After School Care Program (ASCP) is a service provided to parents/guardians of children in primary and elementary schools throughout the Floyd County School System. The purpose of the ASCP is to provide a safe and supervised environment for children after the regular school day.

The After School Care Program is available to any PreK through 5th grade student enrolled in a Floyd County school, if they have been properly registered, and all ASCP fees are up-to-date.

During the ASCP, each child will be provided a snack, supervised physical activities, study time with assistance from an ASCP worker, and other supervised activities.

A minimum of 10 students must register and pay before a school can provide ASCP services.



Program Costs

The cost for students participating in the After School Care Program is **\$7.00 per day**. Two or more children attending ASCP at a school from the same family qualify for a discount. Full price (\$7.00) will be charged for the first child, with an additional fee of \$3.00 per child for each child thereafter. ***Due to the ASCP operating as a separate program at each school, this discount applies only if children attend the ASCP at the same school.***

It is requested that payment be made the first Monday of each month or each Monday for weekly payments. Make checks payable to the school your child attends.

Payments should be returned in the appropriate envelope provided by the school.

A late fee of \$2.00 per minute will be charged for each student picked up after 6:00 p.m. This late fee must be paid before the student will be allowed to continue to stay in the After School Care Program.

Behavior

It is our goal to make the After School Care Program a fun and relaxing place for students, while maintaining a safe and orderly environment. Displaying appropriate behavior while in the program is critical to ensuring the safety of all children.

Parents will be notified if their child violates the ASCP rules. Students who display continued behavioral issues will be withdrawn from the program.
